Due to the new farm bill changes, in order to be eligible for disaster payments through the FSA office, it is now required that you insure all of your crops.

Entity Changes...

As you renew, please verify your information. All policies must match the FSA. Please verify the following:

- * Name - Entity (Corp, LLC, Trust)
- * Marital Status (newly married, newly divorced)
- * Tax I.D. or Social Security Number for you and your spouse
- * Power of Attorney - Make sure your POA matches the entity on file.
